Announcement

- Simplification to the Import Licence Application will take effect on 21 August 2016.
- Key changes:
 - No longer required to declare P&FM storage licence during import licence application.
 - Updating of storage licence in import licence is no longer required. The renewed P&FM storage licences will be automatically updated in TradeNet within 1 working day.
 - Import licence duration can be up to 3 years

General

- a) Upon approval of import license, the import license will be sent to the importer Email address.

Declaration

I shall be responsible to provide any proof of written consent from the applicant upon request by the respective licensing agencies for verification.

I declare that the information I provided is not false or misleading and I have no reason to believe the information is false or misleading, otherwise I may be prosecuted for committing an offence. The licensing agencies reserve their rights to reject the application or revoke the license if granted or to exercise any powers in the licensing agencies' Act(s).

It is compulsory to attach as a supporting document accompanying the licence application, a scanned copy of the Letter of Authorisation from the owner or director. Please take note of the following guidelines for the Letter of Authorisation. The general guidelines for the Letter of Authorisation (termed as the "Letter") are as follows:

- a. Originator of the Letter must be from the person, sole proprietor, partnership or director of the company applying for the licence or registration.
- b. For companies registered with the Accounting and Corporate Regulatory Authority (ACRA), formally known as the Registrar of Companies and Businesses (RCB), the Letter must be prepared on paper(s) bearing the company's letterhead.
- c. Name, NRIC Designation (or Job Title) and Signature of Originator are to be clearly stated in the Letter.
- d. Name, NRIC, Designation (or Job Title) and Signature of person who witnessed the Originator signing the Letter (the witness must not be the third party).
- e. The Letter must state the Name and NRIC of the third parties or the registered name, address and Registration Number (UEN) of the third party (if the third party is a company) who has been authorised by the Originator to act and apply for licences on behalf of the Originator.
- f. List down clearly the licences or registrations, which the third parties would be authorized to apply on behalf of the Originator.

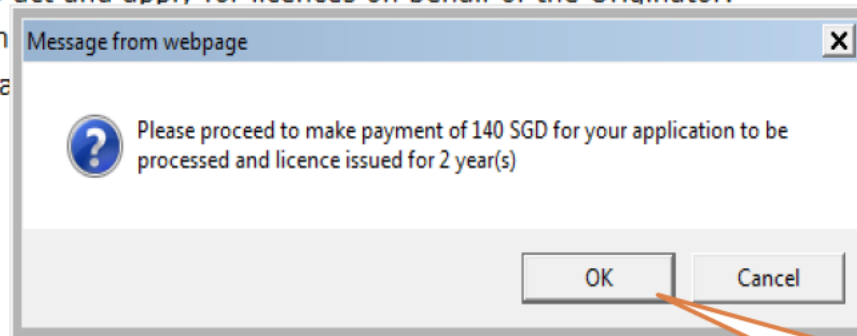

What information is required for Permit Declaration?

- Import Unique Entity Number (**UEN**)
- Petroleum and Flammable Materials (P&FM) Import Licence number (**FI**xxxxxxxx)
- Petroleum and Flammable Materials (P&FM) Storage Licence number (**FS**xxxxxxxx)
- HS code
- Product code
- Unit of Measure (UOM)
- Place of receipt



Avoid some Common Errors

- Invalid import licence number
 - ▣ Import Licence expired
 - Refer to the complete set of import licence
 - Ensure that the import licence (Flxxx) is valid
- Import Licence number entered at the wrong field
 - ▣ Input the valid import licence number at the “licence details”
- Import licence number is printed on top right corner of the licence

Avoid some Common Errors

- ❑ Invalid storage licence number
- ❑ Storage Licence number entered at the wrong field
 - ❑ To provide the storage licence at the “item details; CA/SC code 1”
- ❑ Ensure that the storage licence/s is/are (FSxxxx) valid
- ❑ Importer to obtain authorization from storage licensee for valid storage licences

Avoid some Common Errors

- Invalid Unit of Measure (UOM)
 - ▣ Consult Singapore Customs at 63552190; email: customs_stgc@customs.gov.sg or
 - ▣ Check in TradeXchange

- Invalid “Place of receipt”
 - ▣ Import of P&FM via land, can only be entered into Singapore by Tuas Checkpoint.



Avoid some Common Errors

- Not aware that the product is regulated by SCDF
 - ▣ Please refer to the PowerPoint slides on “**Easy Steps to identify chemicals that are regulated/ licenced by SCDF**”
- Incorrect HS code and Product code
 - ▣ Please refer to the list of licensable products
- Permit rejected by Singapore Customs (SC)
 - ▣ Please contact SC at 63552190 for further assistance
